We will not collect additional personal information or use the personal information that we have collected for materially different, unrelated, or incompatible purposes without providing you notice. This privacy policy shall not be interpreted to restrict or limit our collection and use of any non-personal information, that is, information that cannot be used to identify an individual or a household, and that includes aggregate data, or de-identified information. We may share any of your non-personal information, aggregate data, or de-identified data with third parties for a variety of purposes, including to assist us in better understanding our customers' needs and to improve this Website.

# 3. Sharing and Disclosure of Information

We do not sell your personal information to any third party. However, we may disclose your personal information to a third party for a business purpose. - v. To track and analyze non-identifying and aggregate usage and volume statistical information from Website visitors and customers and provide such information to third-party data analytics providers; and
- vi. To protect against potential fraud, we may verify with third parties the information collected from the Website.
